Lake Restoration

You should have received your notices regarding weed treatment of your personal lakeshore frontage from Lakeshore Restoration of Rogers, the firm that also does the Curly Leaf Pondweed treatments of the bay areas for the Association.

The Association pays the DNR fee to cover all MEMBERS who sign up to purchase treatments by Lakeshore Restoration. If you are not a member of the Association by April 5, 2013, you will have to pay \$40 for a DNR permit, in addition to the cost of the treatments. Just another benefit of Association membership!

Membership notices that were mailed to your winter address in December and February, in addition to an email to non-members on April 1, contained information regarding this membership benefit, among many others.

Our water quality has continued to slowly improve over the past several years due the institution of several good environmental practices. Certainly, the decisions of individuals to treat weeds in front of their own lakeshore and the Association's initiative to tackle the invasive Curly Leaf Pondweed have contributed to this.

President's Letter: No-Wake Ordinance

As we emerge from the winter that would never end, there is definitely a pent-up sense of relief and expectations for the summer to do's, barbeques, and "liquid" water activities.

This winter we were able to work with the Wright County attorney's office to get Pleasant Lake included in their Water Surface Use Ordinance. The provision for our lake is that a 300-foot no wake regulation will be enforced whenever the gate on the outlet leading to Clearwater Lake is closed. This has occurred twice in the past ten years that I am aware of the high waters of 2002 and 2012.

As you know, in 2012 substantial damage, due to high waters, took place on several areas of the lake and is still evident at the Regional Park. We have had testimony from the DNR and our Watershed District that watercraft wakes contribute to the erosion. As good stewards of our lake, your Association will continue to advocate for practices that contribute to clean water and lakeshore management.

In 2012 Wright County adopted an emergency ordinance

which included a whole lake, no-wake provision for Pleasant Lake. The Association advocated for that, as you recall the severity of erosion issues cited above.

This newly enacted ordinance provides for the no-wake provision to be in effect within 300 feet of the shoreline, and only when the outlet gate is closed. Incidentally, the closing of the gate is determined by DNR law and is tied to the water level on the dam at Grass Lake. The gate is controlled by the Watershed District.

We will be sharing information regarding the ordinance at our general membership meeting. It is anticipated that we will have experts in attendance who can explain the ordinance and why your Association leadership chose to advocate to the County on behalf of all people enjoy Pleasant Lake.

As you know, our annual spring meeting is always focused on major issues that are of interest to lakeshore owners.
