City of Annandale's possible change to late 2021 Ordinance on Short-Term Rentals in Residential Neighborhoods

- Just last November the City Council approved an ordinance to limit short-term rentals in residential neighborhoods to not less than 30 days.
- Highlights of December 7th, 2021 letter to City lake shore property owners which outlined the sound rationale for the ordinance.
- Highlights of the Annandale Advocate's August 10, 2022 front page story in which councilors Woullet & Grudy advocate not just changing the 30 day regulation but eliminating it and adding other provisions.
- While you are all free to form your own opinions, I do not agree with their arguments and do not believe
 they would apply to very short-term rentals.
- Corporate buyers of Pleasant Lake properties are not a good fit for our residential neighborhoods. While you cannot regulate who can buy, the current ordinance makes lakeshore purchases much less attractive to those who want to use property as Airbnbs.
- Possibly opens door for other businesses in neighborhoods.
- The changes will first come before the Planning Commission.
- I encourage you to write to the City Council via Kelly Hinnenkamp (or directly if you know any personally) on the City's website or via USPS and to attend any public forums on the subject.
- PLIA will do our best to keep you updated.
