Treasurer's Report: Current balance of \$7,583 Weed treatment from past year totaled \$6,200 this includes DNR permits and processing fees. Donations from the city, county, and triathlon club totaled \$3,500. These funds all are earmarked for the yearly water treatment program. Rainy Day fund has \$2,000 earmarked included in the current balance. Software for record keeping is expected to cost approx \$100.

Dues: The current yearly \$40 dues will remain the same for 2015. Discussion of the \$40 DNR permit cost the association covers for all members will remain in affect. Harkman & Boie MSP. The membership committee will send the dues request out in January.

Membership: 89 homeowners joined this year. There are 120 properties on the lake.
